The Steering Committee is now the "Leadership Council."  The 4 goals for the Leadership Council are:  (1) Spread/integrate "Well County" initiatives throughout Sheboygan County.  (2) HSC2020 Leadership Development/Succession Planning  (3) Community Awareness, Readiness and Engagement (changing culture to health & awareness)  (4) Marketing & Outreach (HSC2020 initiatives and campaigns)  Throughout all 4, strategic planning, data collections, analysis, implementation and evaluation will take place.

Alliance Against Heroin	Meeting on 12/16/14 was a success in bringing new faces to the table to join efforts with a dedicated small group. Reviewed the SCAODA Recommendations and identified those that Sheboygan County is already doing and those that can be sustained. MaryAdele has created a document putting information on the Recommendations already being implemented in Sheboygan into a Logic model that is commonly used by Federal agencies and for grant applications. Follow-up meeting later this month – TBD. Focus will be on actions related to sustainability and identifying goals for 2015. Treatment Court	MaryAdele met with Sharon Abel of Lake Shore Reentry to find out about their non-profit and the work they would like to do. It was decided that this organization will be the "worker bees" for any Federal Grant application that may move forward. They can also be the nonprofit that accepts private donations and work with local funders.  In the Federal Budget for Fiscal Year 2015 (Office of Justice Programs), Drug Courts, DWI Courts and Vet Treatment Courts were allocated \$97.4 million –an increase of \$1.5 million above FY 2014. In addition, \$12 million appropriated for opioid treatment services and \$8.7 million for education and training for opioid treatment programs. Grant applications for Drug/Treatment Courts will be coming out soon and Sheboygan County plans on applying.
