SBIRT Sub-Committee Update (Libby Holte) <ul style="list-style-type: none"> Summary Barriers Celebrations Asks 	Research of articles done about SBIRT was completed by the committee members and presented at their meeting today. The committee will be developing a survey to area providers about SBIRT. The committee is also looking at SBIRT in the schools, training needed for SBIRT and the funding needed for SBIRT. The Medical College grant will be applied for within the next 6 months. The committee is in the planning process for the specific Who, What and Where for the grant development.
Heroin Sub-Committee Update (MaryAdele Revoy) <ul style="list-style-type: none"> Summary Barriers Celebrations Asks 	The committee will be collecting data on the record of opioid and heroin arrests, Emergency Room use for overdoses of opioid and heroin, Ambulance use of Narcan, Medical examiner for deaths related to opioid and heroin. The Dose of Reality campaign is out. Bus signs, billboards, newspapers, posters and flyers are out in Sheboygan county. Education about the opioid and heroin is being developed for youth, elderly, town meetings and medical providers. The committee is looking at the past survey that was done by the Service Providers and possible repeating the survey or doing a post survey. Has there been a change in awareness of opioids and heroin?
